Please be informed that KRBS-ROHQ Training Group already implemented Online Webinar and Online Training Assessment with the assistance of ELITE which is managing our website and crew management system, so that the crew can still take their mandatory training to comply with the KRBS Requirements even if they are at home, therefore crew must attend Online Webinar and to take an online assessment in order to have their certificate issued.

The reason for implementing this “Online Webinar” is because of the “Community Quarantine” due to the Pandemic Condition of COVID-19 and as the measure to lighten the burden of crew especially those who live in the province for future.




- e) **Every Friday – 04:00pm (1600H)**, ROHQ Training Group will send a confirmation email that crew are already scheduled in the system.
 - f) Authorize person in each Manning Agency (i.e. Training Staff / Training Manager) will distribute the passcode to their endorsed crew.
 - g) Please **always** address the training endorsement to Capt. Rolando D. Durana (rolando.durana@krbs.ph) and to Ms. Angela Lanzar (angela.lanzar@krbs.ph)
 - h) In case there are Emergency cases (due to Sickness/Accidents/Immediate Reliever/Certificate near Expiration/Expired Certificate) [*Please refer to Emergency Endorsement Memo for more information*]
 - i) Manning agencies will send an email with attached **Emergency endorsement form** indicating the reason why their crew would undergo Emergency case and **provide a letter from crewing department / email for crew change or actual ticket of embarking crew.**
 - ii) Training Group will only accept emergency cases listed above and will give the crew appropriate training by setting a suitable schedule for the crew.
- 2) **Online Webinar and Online Training Assessment**
- a) The crew must attend designated Online Webinar then after attending the Online Webinar crew must take online training assessment to have his/her certificate issued.
 - b) For the online assessment, crew must get **80%** percentage rate in order to pass their respective training, if the crew failed to get 80% rate, he/she must retake the assessment in order to get the passing rate of 80%.
- 3) **Expiration / Validity of Online Training**
- a) Online Training for example "K"Line EMS is good for Half day (1/2) only. The validity of the passcode will be until **1800H** only.
 - b) If crew failed to access or did not attend his/her training within the scheduled day and assessment cut off time, the passcode will expire, therefore the crew must inform his/her Manning, and Manning needs to reschedule him/her for the next available schedule of his/her training.
- 4) **Issuance / Validity of Training Certificate**
- a) KRBS ROHQ Training and Manning will also monitor if the crew have taken the online training in order to verify completion of training.
 - b) Issuance of Certificate is already Auto-generated in the KRBS Online Training System. Manning will download the certificate of their crew per training.
 - c) For Training which are repeated **Every Contract**, the validity of the certificate will be for **6 months only**.
